2025 Pool Operations

The SMHA pool, at 100 W Robinhood Drive in Sherwood Park, opens Saturday, May 24th and closes Monday, September 1st. Use of the pool is free of charge for owners and renters residing in SMHA. Up to 5 guests are allowed. \$2 will be charged for each guest.

Children under 12 must be accompanied by an adult.

You must register before you can use the pool. Owners and renters need a valid government issued ID. Renters also need proof of residence, such as a utility bill with their name and SMHA property address. Forms & pool rules will be available on our website & at the pool.

Swim hours are 1:30pm to 7:45pm. The gates close at 8pm. On May 27-29 and all weekdays beginning August 1, swim hours will be 4pm to 7:45pm to align with local school calendars (1:30 to 7:45 on weekends and holidays).

We are currently hiring certified lifeguards for the upcoming swim season.

Pool memberships may be available for those who live outside of SMHA. Please check our website and the pool bulletin board for updated information.

What's Happening Now—

- There are minor revisions to the pool rules. Please take a look and if you have any concerns or questions, contact Snow Properties. We plan to implement the revised rules this swim season.
- Many HOA laws have changed since our governing documents were last revised in 1996. Revised bylaws and CC&R's are being finalized by the SMHA attorney and will be sent to you for review and approval this year.
- We are working with homeowners, the city and our county supervisor to address overflow parking concerns from the apartments on Camanche Lane that are impacting Ridgeway, Woodstock, and Lancaster.
- We are working on pool security. Metal screening has been installed on windows, gates and sections of the fence. Motion lights have been added. Options for better security at both entrances to the pool parking lot are being explored.

To ensure that you remain safe when doing any digging projects, always call 811 first.

811 is a free service managed by Underground Service Alert (USA) and available to everyone. After you call, USA will contact PG&E and other companies that have underground lines in your area. Representatives will then mark the location of their underground lines so you can avoid them and dig safely.

Whether you are planting a tree or a garden, or digging holes for fence posts, call 811 at least two business days before you plan to start your project.



Do you hate getting violation letters? Here are a few things to keep in mind:

- Non-operational vehicles & vehicles that are not registered to be driven on California streets must be stored out of view or removed from your property. Parking them at curbside or in your driveway (even when covered) is a violation of city municipal code and SMHA CC&R's.
- Landscaping must be watered, edged, mowed, weeded, and pruned and bare areas replanted. Landscaping done with rock or artificial turf must be maintained as well.
- Personal property and trash cannot be left lying around porches or front and side yards.
- Trash cans may go out 24 hours in advance but must be stored out of public view within 12 hours after pickup.
